The Figs will be centered. The legend will be written bold with 10 pts characters.

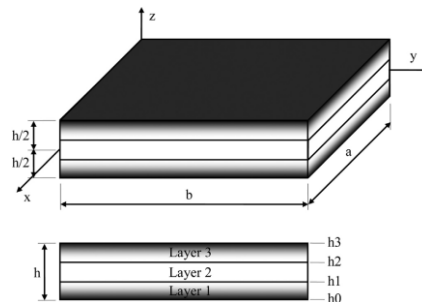


Fig 1. The Figs will have a centered and bold legend (10 pts)
